To be held on Poronui Station, by kind permission of the Managers. Meet at 8.00 am at the Poronui Station airstrip (on RHS about 2 km before Estate locked gate entrance, about 40 mins from Taupo). Poronui is at 2229 Taharua Rd; turn right off the Napier-Taupo highway (SH5) about 20 km from the SH1 turnoff at Taupo.

ENTRY CONDITIONS:

Due to venue limitations, a maximum of 14 entries will be accepted for this trial. If more are received, then preference will be given to dogs that have won or placed in a championship or open game trial or have won a novice game trial. Any dogs excluded will be balloted as reserves and these dogs may replace any scratchings. If required, **the ballot will be held publicly as a ZOOM meeting on 28 March at 7 pm**. All entries will be advised of the ZOOM meeting details at least 48 h prior to the ballot.

Trial will be run under the NZGTA Rules & Regulations for Pointer & Setter Trials on Wild Game. Rules will be available at the trial. All championship dogs must be purebred & registered NZKC No. 1 Register. The full pedigree name and registration number must be supplied at time of entry. All competitors must be current financial members of a club affiliated to the New Zealand Gundog Trial Association (NZGTA) as well as members of the NZGTA. **All competitors must adhere to the Club Safety Plan and Club Code of Conduct.** Dogs will be braced and may be required to run with bells on collars at the judges' discretion. The draw for running positions/bracemates will take place at the venue prior to the trial. Placed dogs will be tested with a pheasant retrieve. **CURRENT SEASON GAMEBIRD LICENSE and FIREARMS LICENSE MUST BE CARRIED BY ALL CHAMP COMPETITORS.** The committee reserves the right to make any alteration to this schedule to meet any emergency. All competitors compete at their own risk. No training permitted on grounds for two weeks prior to trials. **Trial grounds must not be revisited by competitors at any time outside of this trial.**

****Firearms licenses must be presented by all competitors prior to the trial****
Evidence of current sheep measles dosing of all dogs must be presented
P&S Club Trial Safety book and Poronui visitor log must be signed by all attendees on arrival
